

Significant Humanitarian Needs

- > 90% live on \$1 a day (WHO estimate August 2008)
- 90% of births are in village houses
- inflation 20–30% p.a.
- 2008-09 interest rates 10% a month 10% a day

Cyclone Nargis May 2008

- 8th deadliest cyclone on record
- worst natural disaster in the history of Myanmar
- affected 2.4 million people, killed 140,000 (WHO estimate 200,000)
- Iess than 20% of the current appeal is funded
