Regulation 3.1(8) - HeadsPrincipal Officers of Schools



This regulation is made pursuant to Statute 3.1 – Officers and Staff of the University.

HeadsPrincipal Officers of Schools

- The Vice-Chancellor shall appoint a <u>Principal Officer Head</u> to each School in each Faculty. <u>The Principal Officer of a School may be awarded the title:</u>
 - (a) Head of School; or
 - (b) Dean; or
 - 4.(c) other title as designated by the Vice-Chancellor as appropriate.
- 2. The term of the appointment of a <u>Principal Officer Head</u> of <u>a</u> School shall normally be for an initial term of <u>3three</u> years. A <u>Principal Officer Head</u> of <u>a</u> School is eligible for reappointment for a further term or terms of not more than three years each, but ordinarily shall not hold office for more than three consecutive terms.
- 3. A Principal Officer-Head of a School shall:
 - (a) have such powers and duties as are prescribed in this regulation and in any other <u>university</u> Statute or <u>university</u> regulation, and as conferred or delegated to them by <u>the CouncilVice-Chancellor</u>;
 - (b) convene and preside at all meetings of the School subject to the prior right of the Chancellor, a Deputy Chancellor, the Vice-Chancellor and the Principal Officer of the Faculty to preside at any such meeting;
 - (c) be an ex officio member of the Faculty Board and of any committee of the School, and may preside at any meeting of any committee of the School subject to the prior right of the Chancellor, a Deputy Chancellor, the Vice-Chancellor and the Dean_Principal Officer of the Faculty to preside at any such meeting;
 - (d) transmit to the Faculty Board resolutions and recommendations of all meetings of the School; and
 - (e) advise the <u>Dean Principal Officer of the Faculty</u> on any matter pertaining to the School upon which he or she the <u>Dean may seek advice from time to time:</u>

and in each year shall:

- (f) prepare an annual report on the activities of the School for the preceding calendar year which shall include details of the teaching and professional activities, research and community involvement of members of the academic staff of the School and such other matters as may be requested by the Pean-Principal Officer of the Faculty from time to time;
- (g) present that annual report to a meeting of the Faculty Board as directed by the Dean_Principal
 Officer of the Faculty; and
- (h) present the curriculum of the School for the following year to the Faculty Board prior to the last meeting of the Faculty Board in each year.
- 4. Subject to the general superintendence of the <u>Dean Principal Officer</u> of the Faculty, a <u>Principal Officer</u> Head of a School shall have the following responsibilities:

- (a) coordinate the academic affairs of the <u>sS</u>chool in accordance with policies established by the <u>Planning and Resources Committee</u>, the Academic Board and <u>the</u> Council and the rules established by the Faculty Board;
- (b) provide academic leadership pertaining to teaching, research and other academic activities of the School;
- (c) ensure effective leadership and management of all operational aspects of the <u>S</u>chool, including staffing, teaching and student engagement, academic affairs, research, management, administration, budgeting, resource allocation, working conditions and occupational health and safety matters and academic quality assurance;
- (d) allocate work loads and duties to all members of the School;
- (e) establish and maintain appropriately high standards of teaching, research, consultancy and community service in the School;
- (f) ensure the delivery of high quality teaching and supervision to all enrolled students and the provision of assessment results in accordance with the University's Academic Calendar and assessment procedures on or before dates prescribed by the Vice-President and the Academic Board;
- (g) maintain general superintendence of the staff of the School including ensuring that every staff member takes part in the Performance Planning and Review process;
- (h) contribute as required to the management, administration and priorities of the University; and
- (i) exercise such other powers and to perform such other duties as may from time to time be assigned delegated by the Dean Principal Officer of the Faculty.
- During any absence of the <u>Principal Officer Head</u> of <u>a School</u>, the Vice-Chancellor may appoint an Acting <u>Principal Officer Head of School</u> to act in place of the <u>Principal Officer Head</u> of <u>the School</u>.

Senior School Officers

6. The Vice-Chancellor may from time to time appoint senior officers in Schools.

Associate Principal Officer of a Heads of School

The Vice-Chancellor may appoint one or more Associate Heads of School Principal Officers to a School. On appointment of an Associate Principal Officer of a School, the Vice-Chancellor may designate:

the appropriate title to be awarded to the officer; and

the fractional loading of the position, which shall not exceed 0.6 equivalent full time employment.

An Associate Head of School is to be designated as no more than 0.6 of equivalent full time employment.

The term of the appointment of an Associate Head <u>Principal Officer</u> of <u>the School shall normally</u> be for an initial term of 3 years. An Associate Head <u>Principal Officer</u> of <u>a School is eligible for reappointment for a further term or terms of not more than 3 years each, but ordinarily shall not hold office for more than 3 consecutive terms.</u>

An Associate Head Principal Officer of a School shall:

have such powers and responsibilities as are conferred to that office by the Head Principal Officer of the School in consultation with the Dean;

be responsible to, and work closely with, the Head <u>Principal Officer</u> of <u>the School to ensure</u> effective leadership and management of particular designated operational aspects of the <u>School</u>.

work closely with the relevant Associate Dean to ensure effective leadership and management of particular designated operational aspects of the School.
