

UNDER 18 STUDENTS INFORMATION FOR PARENTS

AUSTRALIAN IMMIGRATION REGULATIONS STATE THAT:

You will **not** be allowed to study in Australia while you are under 18 years of age unless:

- you are accompanied by a parent or legal custodian,
- you stay with a suitable relative, or
- your education provider provides a written statement saying that your accommodation, support and general welfare arrangements are appropriate.

Department of Immigration and Citizenship (DIAC) regulations for students who are going to live with a relative nominated by their parent/legal custodian require that the relative:

- be the student's brother, sister, step-parent, step-brother, step-sister, grandparent, aunt, uncle, niece, nephew, step-grandparent, step-aunt, step-uncle, step-niece or step-nephew,
- be aged over 21 years,
- have the right to remain in Australia until the student's visa expires or the student turns 18 years-of-age, (whichever happens first), and
- show that they are of good character, by providing evidence of a police clearance in the country or countries in which your relative has resided for more than 12 months in the past 10 years after the age of 16.

DEAKIN UNIVERSITY REGULATIONS

- All under 18 students must either:
 - live with an eligible relative (as defined by DIAC) who is nominated by their parent, or legal custodian
 - or**
 - live in accommodation arranged through and approved by Deakin and go into care arrangements with a professional care agency listed by Deakin University.
- Approved accommodation for DUELI students includes Under 18 Homestay (arranged by an approved provider) and International House. Approved accommodation for Bachelor students includes Deakin University Student Residences and Under 18 Homestay (arranged by an approved provider) and International House. The student **must** remain in approved accommodation until turning 18 (including any period of non-enrolment).
- Care agencies used by Deakin University include: International Student Alliance, Professional Student Care, A&J Student Care, EduCare and ICC.
- Care arrangements with a listed provider must be in place for the entire period until the student turns 18 (including any period of non-enrolment).
- While the student is under 18, any changes to accommodation and/or carer arrangements must be approved by Deakin University or the enrolment of the student may be terminated.
- Students are not allowed to travel to Australia before the start date of their approved welfare arrangements.

PROCEDURE FOR STUDENTS WHOSE PARENTS CAN NOMINATE AN ELIGIBLE RELATIVE WITH WHOM THE STUDENT WILL RESIDE:

1. On receipt of an application for an under 18 student, Deakin International will send you a copy of:
 - *Under 18 Students – Information for Parents* (which you are reading now) **and**
 - *Parent's Declaration form*
2. You advise Deakin International Admissions that you can nominate an eligible relative with whom the student will reside until turning 18 by completing the Parent's Declaration form appropriately.
3. DIAC will require you to produce proof of the relationship, of the relative's right to remain in Australia while the student is studying and of their good character before issuing a student visa.
4. Upon arrival in Australia, your son or daughter is encouraged to make contact with the International Student Adviser (ISA) at the campus where they are going to study.

PROCEDURE FOR STUDENTS WHOSE PARENTS CANNOT NOMINATE AN ELIGIBLE RELATIVE WITH WHOM THE STUDENT WILL RESIDE:

1. On receipt of an application for an under 18 student, Deakin International will send you a copy of:
 - *Under 18 Students – Information for Parents* (which you are reading now),
 - *Parent's Declaration form*,
 - *Confirmation of Appointment of Carer form*
2. Please advise Deakin International Admissions that you cannot nominate an eligible relative with whom the student will reside by completing the Parent's Declaration form appropriately.
3. Please complete the Confirmation of Appointment of Carer form by nominating an approved Care agency from the list below and sending the signed Confirmation of Appointment of Carer form to the agency together with certified copies of parent's ID e.g. passport/s showing signature. You will also need to send payment to the Care agency. The Care agency will sign this form and return it to Deakin International (with police clearance and copy of the passport of carer).
4. Deakin International Admissions will send you a *Homestay Information and a Homestay Application* form or an *International House Application* form, or a *Student Residences Application* form (Bachelor students).
5. Please complete the appropriate form and return it to Deakin International for processing.

Under 18 students must stay in accommodation arranged through and approved by Deakin University. Approved accommodation for DUELI students includes Under 18 Homestay (arranged by an approved provider) and International House. Approved accommodation for Bachelor students includes Deakin University Student Residences and Under 18 Homestay (arranged by an approved provider). The student must remain in approved accommodation for the entire period until turning 18.
6. Deakin International Admissions will verify that care arrangements and accommodation arrangements are in order and issue a Confirmation of Appropriate Accommodation and Welfare Arrangements form (CAAW form).
7. Upon payment of tuition fees an Electronic Confirmation of Enrolment (e-COE) will be sent to you together with the CAAW form. Please take the e-COE form and the CAAW form to an Australian Diplomatic Mission to apply for a visa for your son or daughter.
8. Your son or daughter is strongly encouraged to make contact with their Care agency immediately upon arrival in Australia. They are also encouraged to contact the International Student Adviser (ISA) at the campus where they are studying.
9. Your son or daughter will not be allowed to travel to Australia before the start date of their approved welfare arrangements, which is printed on the CAAW form.
