Bruce Chen was conferred his PhD at Monash University. Bruce's thesis examined statutory interpretation pursuant to the principle of legality and the *Charter of Human Rights and Responsibilities Act 2006* (Vic). The former is the common law presumption that Parliament does not intend to interfere with fundamental common law rights or freedoms, and the latter is Victoria's statutory bill of human rights. Following the High Court decision of *Momcilovic v The Queen*, interpretation using s 32(1) of the Charter has

been equated with the principle of legality. However, Bruce's thesis found that while there are some similarities, there are also significant differences or potential differences between these two interpretive mechanisms. In addition, they have not had the same impact on statutory interpretation outcomes. The thesis concluded with a call for the courts to reconsider and clarify the issue.
