#### **5. Upcoming Law School Events**

Professor **David Oppenheimer** (Clinical Professor of Law, University of California at Berkeley) will present a seminar on 'Martin Luther King's Dram of Affirmative Action: Beyond the Content of One's Character':

The contemporary debate about affirmative action increasingly pits those support race-based affirmative action against those calling for class-based or geography-based affirmative action, which are frequently described as "colour-blind" alternatives. Opponents of affirmative action often invoke Dr. King's "I have a dream" speech as evidence that he, like they, supported colour-blind policies and thus presumably would have opposed race-conscious, affirmative action. In fact while Dr. King dreamed of a time when racism - and thus race- would be irrelevant, he was an active supporter of all three of these forms of affirmative action. To those who invoke Dr King as a supporter of colour-blindness and opponent of race-based affirmative action, and to those who advocate race-conscious affirmative action over colour-blind affirmative action alternatives, nearly fifty years after his murder Dr King's voice continues to send us an important message: we don't need to choose one approach over the others; we should do all three.

The Honourable Associate Justice **Mary-Jane lerodiaconou** of the Supreme Court of Victoria will deliver a talk on 'Health & Wellbeing in the Legal Profession', followed by a Q&A session.

Speaker biography: The Hon. Associate Justice lerodiaconou is an Associate Judge of the Supreme Court of Victoria. Before her appointment to the Court in May 2015, Associate Justice lerodiaconou was a founder and Managing Partner of a leading employment law firm. Associate Justice lerodiaconou has been a member of the Law Institute of Victoria Council, where she dedicated her maiden speech after election to the importance of flexibility and mental health in the legal profession. She was also a member of the Law Institute of Victoria Committee for Mental Health in the Legal Profession, where she participated in policy and practical initiatives to improve wellbeing in the legal profession. Associate Justice lerodiaconou has published extensively on mental health including articles to do with disclosure, unlawful discrimination and the importance of raising awareness of mental health issues.
