# Deakin University Student Services and Amenities Fee (SSAF)

2023 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this *SSAF Allocation Report* does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial Viability Instructions: Applicants and Providers of FEE-HELP</u> (FVI) for all other approved providers.

#### SSAF Consultation and Achievements

The SSAF is managed by Diversity, Equity and Inclusion (DEI) which reports into the Deputy Vice Chancellor University Services Portfolio. Decisions about how SSAF funding will be allocated are discussed by the SSAF Selection Committee, a delegated group of senior University representatives, with final recommendations developed by the Executive Director – Diversity, Equity and Inclusion taken to Deputy Vice Chancellor University Services for endorsement.

The university regularly engages and consults with the key student representative body, the Deakin University Student Union (DUSA) at a monthly partnership meeting attended by the Executive Director Student Services, Dean of Students, Executive Director Diversity, Equity and Inclusion, DUSA President and DUSA General Manager. Items of significance and for action are distributed across the university to relevant stakeholders and leadership.

In July 2022 students and DUSA were invited to comment on the proposed priorities for use of the 2023 SSAF revenue. The proposed priorities for fee expenditure were published on the web and via other student focused communication channels. Students formally elected to University Committees and Boards were also directly invited to comment and several discussions were held with the DUSA leadership.

Themes from student feedback and consultation mirrored the priority areas, notably student welfare and mental health, career development and employment. The other area of feedback that was not aligned to a SSAF priority area was parking. Students were directed towards the DUSA Transport Support Financial Grant, which supports students in financial need to cover the costs of transport and parking around campus.

#### Highlights and achievements from the 2023 year included:

- Increases in financial support and assistance for students to ais with increased cost of living expenses.
- Greater engagement with Orientation and Campus based events.
- 20% increase in Fitness Centre memberships.
- Focused spotlight on the prevention of and response to incidents of Gender Based Violence and Sexual harm.
- Connected and engaging Peer Support services including 24/7 availability.
- Sustainable, paid employment opportunities for our students.

The term "part-time basis" means a study load of less than 75 per cent of the normal full-time student load for the period to which the fee relates. As per part 7 of the Administration Guidelines, the normal EFTSL value for a full-time student studying over a period of one year is 1.0.
