- 1 Information on how to enter this Competition forms part of these Terms and Conditions. By entering, entrants agree to be bound by these Terms and Conditions and entries must comply with these Terms and Conditions to be valid.
- 2 This Competition is governed by the laws in force in the State of Victoria.

#### The Competition

- 3 This Competition is free to enter and is open to full time or part time domestic Deakin students who meet the following criteria:
  - (a) are enrolled in either an undergraduate or postgraduate course at Deakin's Geelong Waterfront campus; and
  - (b) are studying one of the following courses:
    - (i) Bachelor of Commerce, Bachelor of Management;
    - (ii) Graduate Certificate/Graduate Diploma/Master of Financial Planning or
    - (iii) Graduate Certificate/Graduate Diploma /Master of International Finance;
  - (c) are currently enrolled in or completed one of the following units: MAF101, MAA255, MAA318, MAF765; and
  - (d) possess a weighted average mark of greater than 65 for the course they are enrolled in.
- 4 Applicants may only register for this Competition once.
- 5 Employees of Deakin and their immediate family members are not eligible to enter this Competition.
- 6 The applicant, in submitting their entry, grants permanent ownership of that entry and any report contemplated by clause 16 below to Deakin. This includes a worldwide, perpetual, irrevocable and royalty free licence to use, reproduce, publish, sub-licence, communicate, adapt, exploit and to perform any other act with it in connection with the Deakin's ordinary course of business.

#### Competition Period

#### The Prize

- 8 The winning student will be provided with airfares, accommodation and registration to the Congress of the Financial Planning Association Australia (FPA) National Professionals Congress in Perth from 23-25 November 2016 – the total prize pool is valued at approximately \$3,000.



### How to Enter

- 9 Entrants must apply by emailing [bl-scholarships@deakin.edu.au](mailto:bl-scholarships@deakin.edu.au) from their Deakin email address, using the subject line FPA prize. Entries must include your student ID number and a written explanation in 250 words or less of “Why I would like to become a financial planner.”

### Selection and Notification of Winners

- 11 Winners will be notified by email. The names of the winner will also be published online at [businessnewsroom.deakin.edu.au](http://businessnewsroom.deakin.edu.au) within 14 days of the date of the draw. Winners must be available to collect the prize from the Faculty of Business and Law located at 1 Gheringhap Street, Geelong VIC, Australia or must make arrangements for shipping of the prize to them at their own risk and expense.
- 12 If the winner of a prize does not claim the prize within 14 days of the date of the draw, the runner up selected by the Geelong FPA local chapter committee will be notified and awarded the prize.
