And there's some pretty important dates that will cover off on and basically your cost structure and rules to follow and where to get help and how students can help you in the through the course of your, your

Studies. Okay, so your, your enrolment at Deakin is

Pretty much all connected to what we call DeakinSync. So this is like the umbrella of everything so

Once you activate your username and password to access they can sink that is like the gates to everything. You'll be able to access StudentConnect, which is the enrolment system.

To add in enrol in units, you'll be able to access your, your unit information you'll see there's a little screen grab of once you enrol in your units.

The actual units will appear in this unit site and you can click on to a unit site like academic integrity.

And it will have all the information there on on how to study that unit or the content and how to upload assignments and things like that.

So the big thing is is that now that you're at university, and it's up to you to maintain your enrolment and we're happy to help and guide you through that journey but

Ultimately, it is you that needs to press a lot of the buttons to make things happen, or to discontinue things when you need to or add things when you need to.

So we've got a StudentConnect demonstration today, so I will pass you over to Natalie, who will be covering this and I'll stop sharing my screen now. And so pretty much StudentConnect is all about how to manage your enrolment and we will go through that process now.

At Deakin so I'm just going to take you through how to enrol your units and set up your account. So you will receive this link in your email to activate your account. So you just need to put your details in go through, get your username and create a password.

And then from there you will be able to enrol into DeakinSync and when you get into Deakin think you will be asked to offer up the top here.

And the student has quite a lot of offers, but you just have the one that is relevant to you, which is day three to two Bachelor of Commerce Bachelor of Laws, I believe today.

So once you click accepted you will go through and find the offer, which is right here and click enrol.

And or if I'm going too fast because you guys will pick it out as you go, go back through

That you'll just go through and read each of the three steps here. I won't take you through them now. But if you can read through them before you click enrol now.

And that's going to take you to StudentConnect, and this is where you'll be out to Amanda enrolment. Look at your core state house so your results and invoices. But today, I'm just going to show you how to enrol. So we'll click on enrol the nice pink box here.

And find your course and begin enrolment.

So the first thing that comes up is the terms and conditions. So you can rate three days. And once you are happy with that will consent and accept

And then your course will pop up. So this is where you're confirming your course and saying, yes, I want to study at D. She's very exciting Kremlin.

So you will put your home address in postal address if you want your results sent to you by your mobile number which I suggest you will say yes to

Your personal emails we can contact you via email and personal email your primary emergency contact and you agree with a blocked have to in their

Name will continue to our statistics. So, for the purpose of this demonstration I will be an Australian citizen.

So I you have Aboriginal Australia on the descent, you can answer that one. What your citizen citizenship statuses. I'm just throwing citizen.

Where you were born. If it was not Australia, you just choose from the list which country you were born in and then you have to put in the that you arrived in Australia.

Then where your permanent residence is so if it's in Australia. You put your postcard where you live. And if it's overseas. You'll just need to choose your country again from the list.

And then you'll need to put in the postcode of where you'll be staying while you're studying at Deakin. And you can always come back and update these things if things change just through your personal details.

Then we like to know what languages spoken at home. So if it's a different language other than English, you can just find it again through here.

And then what your highest level of education is. So most of you today would have finished your 12 last year, I'm assuming, so it's just simply choosing the that you can play the hospital. And what year that was in

And also where you were when you were studying in high school in Australia.

Then we ask you if you have done any other tertiary study and I'm as I said most of you from your 12 so it will be none of the above. Unless you've done any certificates or deployments to get on as a pathway.

And then because we're commencing an undergraduate. We don't need to say where we did our other studies because we haven't done any yet. So we just say we're not commencing and postgraduate course.

And down here we asked if you have any disabilities that you'd like to flag with us. And if you just have a read through and there's any that are

Relevant to you. You can choose, please contact me and someone will contact you from the Disability Resource Centre to assist you with your studies at Daikon

And we do have a lot of support services available. So if you want to have a read through those just to make yourself aware of what kind of support. We offer at Deakin that's a really good idea as well.

And then finally, we asked you what your parents and guardians highest education is so if you can please complete at least one of them just the first one.

If you're not sure you can say, I don't know or have no information or it's not applicable. But if you just make sure you do at least one that will be fantastic.

Then we save and continue that and move on to the next helpful, which is where you need your tax file number handy.

And then you would need to enter your tax file number or if you've applied for one, just take that you have applied for one and upload

Now this bit is where we start looking at your enrolment. So if you have majors or mine is in your course which I'm not sure if there isn't this course there is. So this is where you would add

Your major or minor. You can either search it by the units at code which you would find in the handbook, which is the link to

On the next page, or you can search by the title. And I feel like your favourite last time was accounting, but maybe it's not in this

Account on that one, but you would just search

Here alone.

Whichever one you lock search it, and then you would ticket to add it to your course.

That the student advisors will be happy to help you with that one. I'm sure Allison will go into a bit more details soon.

And so once you've chosen that if you need to use one you continue to the unit step and all of your units will be here but you can say they're sitting as unconfirmed so we just need to go through and confirm the mall.

And you can also have a look. So I've got the unit code. The name the campus where you'll be studying and the delivery mode. So if it's cloud on campus. It will just say cloud, but because this is on campus. It's a day.

And like I said, they owe unconfirmed at the minute, so we just need to go through and take the mall or some similar

And if you look down the bottom there it says there's eight pending changes. So I haven't actually done anything yet, because I need to click finishing rolling to finalize it

But I'll show you quickly how to add a unit if all your units weren't there if you had an elective unit or a major unit to add

You just search it, you can either search by the unit code or the unit title.

Just going to search the Academic Integrity Unit whichever one needs to do.

And then when I click finishing rolling

It's going to tell me that

Successfully saved all my units and all of these units. The status is now enrolled rather than unconfirmed

So if I go back to my current enrolment. I can see them all sitting there nicely and I have the option to discontinue them. Now if I didn't want to be enrolled in a unit for any reason. So to do that, all you need to do is click discontinue say why is discontinuing

And make sure you do click finishing rolling for this one as well, otherwise it won't go through

StudentConnect tips and tricks.

So while Natalie showed you how StudentConnect works. There is no transaction email or receipt. When you enrol in a unit or when you discontinue from a unit. So it's really important that you

Double check that you've done everything properly and we cannot stress enough press that finalization button and make sure you've actually pressed it because

You know we do find students that will say, I thought I withdrew and we're like, oh, well, you didn't. And so

You really need to make sure that you do. So you're not liable for the fees if you don't want to be in a unit. And likewise, you need to make sure you've added a unit correctly so that

You know you're part of that unit and be because we do have dates that say that there's a last day to add a unit. And if you haven't added the unit by a certain date. You can't get into the unit and study it for that trimester, so

One thing I would suggest is you finalize everything and then you give it an hour and you go back in and make sure that what you thought you've done is visible and also you can check in.

Cloud, they can to see if the units are evident in your cloud taken in the titles, but I'll work through that in a second. So

For Commonwealth supported play students really important to get your tax file number in when you when you're completing all the forms that Natalie is just showing you, so

You need to have your tax file number by the 31st of March, which is sent to state, otherwise you'll be liable for the fees and you'll have to pay them up front. So if you want to defer your fees to the the fee help loan scheme through CSP, then it's important to get that text file number

Okay, our enrolment terminology. There is a lot of jargon at daikon, so it will take you some time to get your head around everything but

You know, that's just part of life sometimes. So your course, you're doing a bachelor's degree and you might hear the word masters pop up or graduate diploma graduate certificate

And they postgraduate study, but you're just doing a bachelor's, so an undergraduate and you're doing a combined degree. So you're doing two courses and a one degree terminology, so

Your unit a unit is said is a subject that you study. So for example in double A is an accounting unit credit points. That's a point value system to count your units, some units, maybe with two credit points. So you just have to keep an eye on that.

So unit enrolment that adding a unit unit withdraw that withdrawing or discontinuing from a unit.

intermission, that's where you want to take a break from your course with the approval of the faculty. So from us. And so you'll find that trimester, one which starts in March and trimester, to which starts in July, the

Compulsory study period. So if you want to take a break in terms to one or trimester to at any time you have to apply for that intermission, or is trimester three which is

From November to February is a optional study period for your course. And then we have discontinuing is ending your course. And that's when you, you know, you no longer want to continue studying that course.

Okay cost codes and unit codes so that M 300 Bachelor of Commerce defines that it is connected to business and law. So you're doing a double degree and that starts with the letter D.

Unit codes, we've suggested that the first letter of the code tells you what faculty. The unit belongs to. So m at

Is an accounting unit and it is a level one, because the first number in the code is one

So you will find through your course there will be rules about how many level three units, you need to do and how many level one units. You're allowed to do so that that first number in the code is a pretty important one to identify what level. The unit is

Okay study periods or teaching periods and generally you always study trimester one and trimester to just keep progressing through your course as efficiently as you can.

Some students like to use trimester three which is from November to February and to either help spread out your study load or just to

You know, maybe do an internship, which is a credit point. So you might do a work experience unit in tier three or you might want to do a study abroad unit in a trimester three or one of your other units that's available.

Okay, full time or part time study and that would be fantastic to just do part time study. I think in, take your time, but

That's not always available to everyone in a

The best manner possible so full time means you're enrolled in three or four credit points in a Trimester And That's really important to know because you may be seeking

Centrelink payments, like a study or you might want to get public transport discounts or you might want to access some scholarships. So some of these things are only

Eligible for students who are considered full time. So, part time. It means you're only doing one or two credit points in a trimester, and

You may be disadvantaged for other things. If that's all you you intend to do in terms of public transport discounts and things like that. And, but, yeah, it could be a good balance if you're working full time.

Okay, important dates and the handbook. So enrolling and adding units and discontinuing discontinuing units and

Everything like that can be found in the university handbook. The census data is one of the most important dates that you need to be aware of.

trimester. One is the 31st of March 2021. So that's the date that you become fully liable for fees if you withdraw after that date and the unit will appear on your transcript after that date.

So the university handbook is always where you can find course just descriptions rules and structures and really important to understand that date. So if you want to withdraw from a unit. It's best to do it before that date.

Okay, so our systems DeakinSync is your personal hub to all systems Deakin and is a starting point for everything. So

Once you get your username and password activated, then you'll be able to access StudentConnect cloud Deakin. We're all your unit sites are

Star is our timetabling system that sits on the DeakinSync and that's where you would allocate yourself for Campus classes. Now, I know we haven't communicated that when and how students will come back on campus yet for face to face teaching, but we do need you to

Allocate yourself to classes now so that when we resume to face to face learning and you're ready to go. And you get your preferred time slots for your classes and your seminars.

Deakin email, you'll have a special little date can email account. And that's where all official communication is sent to and you need to keep an eye on that says, at least once a week, but I'll be checking every couple days, you know, just to keep across everything

Now Deakin is very kind and offers a lot of software for free for students. So before you go out buying software for a new laptop. Just go to our software library and find out what we can offer you before you go and purchase things separate

Like a course rules is, this is what we're all come here today to understand your course and how it all works. So it's a 40 credit point course and

The first thing you would need to do is complete ma vie. Oh no, that's an academic integrity module. So it's a zero credit point unit.

And we do encourage you to complete that in your first few weeks of classes because it will really help with your assignments that are do

In the first couple weeks. It's, um, it's all about how to reference work correctly so that you're not seen as I guess chafing basically or, you know, plagiarism. So it's about ensuring that the work that you submit an assignment.

Whoever's working is is recognized appropriately. Okay so 16 credit points from the Bachelor of Commerce. So you'll have seven credit points of commerce call units.

There's an accounting unit an economics, finance information systems marketing unit management unit and a professional insight unit. So the idea is you do these foundational units first and they

Each of these leads into a major. So you can see that there's a level one accounting unit as a core unit to complete and

And then you could move on to accounting major sequence. So all our majors eight credit points and then you have an option to do one credit point of that's an elective unit.

So like I said before, there's some little course rules and you need to complete at least four credit points at level three in your course and but in terms of understanding this all the majors have the level three.

credit points that should cover you off on that role. So don't panic too much and and then we've got the 24 credit points from the Bachelor of Laws.

So that includes 18 credit points of core units and then you do have a little bit of choice in there. So you have six credit points of law elective units that you can choose. And so we have

A number of quite a lot of electives to choose from. The big thing is when you want to do them. There will be availability in tier one, tier two or tier three and and that may inform your decision as well. So, the other one is you do a will or practical unit as well.

So,

Just a little pointer, there is that with the Bachelor of Commerce Bachelor of Laws, you cannot complete MLC 101 which is law for commerce under the Bachelor of Commerce.

This unit is not part of your degree and it is part of the straight commerce degree, but not for the combined degree. So please do not enrol in it and it's incompatible with NLL 111 contract and which is part of your core units under the law degree.

So yes, lots of information to take in today. So don't be overwhelmed and

Because you will get to understand all of this at some point. So commerce majors.

We've got accounting economics, finance financial planning food and agribusiness human resource management management information systems and marketing.

So you'll see that accounting and financial planning and majors that are recommended pathways to qualify to become an accountant or financial planner and

And just be aware that if you are looking on the handbook, they will be mages referenced in the handbook, such as business analytics commercial law and international trade.

But they are only available to students that started their degree before this trimesters so you while you might like to do one of those majors. They're not available to you. So, I'm sorry. It's kind of like putting a carrot.

Or going up there, but you can actually complete them. But just so as you don't get confused when you're looking at the hymn book yourself.

And and now the food and agribusiness major that's affiliate new major and it is available at Warner Cable as a face to face learning or in the cloud online mode. So you can do the major but all the units would be online if you're based it the waterfront or and that would campus.

Okay, so your course map will help you to plan out your course in units and you simply go to Google and you can Google Deakin course maps and into your course code and commencing year and you just select the

Course map and you'll be able to review all the costs rules and the suggested sequencing of units for

The entire time of your course.

So the only time you would really deviate from that standard cost map that's featured on the website.

Is maybe along the way you might want to drop down a couple units or you might want to put some units into trimester three

Or you may have some Recognition of Prior Learning. So that's our PL. And if any of you have done previous study and aren't coming straight out of high school, you can have

Prior Learning match to particular unit so that it reduces your costs duration. And if any of you have done the accelerate units in VC so that you may have done a

To law units a nvca, then they will be seen as credit in your course. And you would need to have your course map adjusted for that very reason, but that was where our student advisors come in and help you with that. So, and I'll talk a bit about that shortly.

So this is how the course map looks, you would download a course map. And you'll see that

Your course map is suggesting that you do three of your law core unit first and one of your common core unit. So it's suggesting that you do accounting first

And then in your second trimester. You just do two law units and you can knock over to have your commerce unit. So you do economics and finance in your second trimester.

And then it proceeded through and gives you the whole

Progression for the for the years that you're here.

So just quickly CALL UNIT compulsory so you have to complete them in order to complete your course elective units units which you can choose to study and make up

A major or minor and we have a lot of work integrated learning units that you can complete as electives. And they study abroad units as well if and there's options to go on exchange and things like this later on.

But this will be discussed at orientation. So while this is a lot of information to cover today, you'll get additional information at orientation and

So don't feel overwhelmed today with all of this information prerequisites and CO requisites. This is really important in terms of course planning a prerequisite unit has to be completed before another unit so unit. He needs to be completed before unit be co requisite is where

You need to complete the unit in the same trimester or in a prior trimester.

So, you know, sometimes you might be looking at your course plan and you're like, oh, this study leads too much for me. I think I'll drop a unit.

But you have to be careful because if you drop a unit that required for one of your trimester two units will then it can really delay your completion date of your degree because it's so it's really important to get cost planning advice from a student advisor.

Okay so majors or unit sits. Some universities, call them specializations. But at daikon, we just call the majors and you'll see in the in StudentConnect. They're called unit sits

It's a group of related units within a course and at least one majors can posers within the Bachelor of Commerce side of your degree and the major in commerce is an A. CREDIT point major and once you've achieved it and you've completed your degree. It'll, it'll appear on your transcript.

So minors is just typically for credit points, but they're not offered in your degree and there's just simply no room for it so you don't need to worry about that.

Okay, so, confirming your enrolment and like I said before, it's about accepting your of creating an activating your username and password and entering Daikon sick sync. And the big thing is confirming your enrolment for units in both trimester one and trimester to

As I said before, costs plans show you a prescribed unit sequencing.

To make sure that you complete your degree in the timeframe that we suggest. So for us it's five years and you can deviate from that course plan at times and to suit work life balance or whatever the case but

That is something that you can seek advice from from a student advisor, later on, like, you may find that you fail a unit. So then you need to get a course plan read done to make sure that you're on track.

But at this point in time, I would be saying to come follow the cost plans outlined in that web link. And if you have recognition for prior learning

That you would like to submit and you might need adjustment to that course map, then you would see s course advisor to assist you with that or if by chance you want to do part time study

Okay so contact hours, all of the units outline their contact hours for that specific unit in the handbook and classes lectures and seminars tutorials. So

Tutorials where they essentially revise the content that you've learned in the lecture. So it's a good little session to attend. And I know while things are online and

You know you. It is up to you to stay disciplined and manage your, your contact hours and all of your study. It's a little bit different to high school, so

You really do need to be self motivated to keep on top of things because unit chairs won't be asking if you've done your hours that week and

So we suggest a 10 hours of study per week per unit. So it doesn't sound like a lot, if you're doing four units. That's 40 hours a week and, but, you know, putting in the hours early on in the trimester can really set you up to do well in your exams at the end.

Yeah cramming your studies at the end doesn't always work for everyone. So it is important to just chip away at the learnings and the concepts, week to week so that you stay on top of things.

Okay, so your timetable and like I said before you you create your timetable for on

On campus classes and seminars in the system staff and it's really important. You put in your preferences by the 25th gen so that

When we do resume on campus, you get the selected days that you want to be on campus and and the sessions that you want to be in. So you can have your draft time table via the style website and

Obviously for students that are just enrolling in cloud or online units and you don't need to put in preferences insta and you'll be able to access all of yours.

Lecture materials and recordings through your day can sink tile.

Okay.

This been a big session for your unquiet. Sure. And yeah, I've spoken for quite a while now and but we are here to help you. So

We have the Student Services Network to help you with course planning and advice and Enrolment and Student IDs.

Fees and financial assistance exams results and transcripts is International Student Services last property. There's a whole range of support services available.

To Deakin students. And so we really encourage you to take them all up and there's the Disability Resource Centre is counselling free counselling may add, and so

With this current course so you know you have if you accept the Bachelor of Commerce better of laws course now and you change your mind and you don't discontinue it properly.

And and you go off to another course at another university or even at Deakin

And you still will be charged the fees if you don't discontinue it properly in the system. So we would hate that to happen to you.

And but we really want you to stay with Deakin, and in this course, we think it's fabulous. And we think you'll have a great time in it and you'll do really well and

That's what's important. So talk to us first

We understand in your first G that you may not have all your yet to select a major and that is ok we don't expect all students at this early stage to know what major

But if you do not know what major you can certainly enter it. If you're still unsure, and you think, you know, you might decide any two or three you can update StudentConnect in so you can simply just bypass the step in the process.

acossey: Yeah. Yeah, that's a really good point. Caitlin. So we all know just getting through those core units that will give you an understanding of what major you might like to pursue and we also will be running a chooser major session in the first week of

The trimester. So you through the mentor program. So if you join them into a program you'll find out more information to join and that will give you an overview of

The different majors that we offer and the graduate outcomes for these majors. And how about going to find research and understanding of which one would work for you. And so, yeah, that's the main thing is

Just take your time processing the information from today. If you have any queries or issues you're welcome to put them in the chat function now and

Definitely just seek advice from the student advisors network and get an appointment with a student advisor to help you confirm your enrolment and yeah you'll get to hear more at orientation as well.

When we say there's a class in the lecture. They are standard everyone joins those ones but tutorials

And typically, you know, you might have 20 to 30 students in a tutorial so they'll run a few of them across the course of the week. And so

It's up to you to work out what days, you might have a part time job, you might say, Well, I want to do the tutorial on a Tuesday.

Or seminar on a Tuesday as opposed to a Wednesday. So it's important to get your preferences in and because if you leave it till after, then you might not get your preference. So that's what the preferences were about
