# Deakin University Student Services and Amenities Fee (SSAF) 2022 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial</u> <u>Viability Instructions: Applicants and Providers of FEE-HELP (FVI)</u> for all other approved providers.

### SSAF Consultation and Achievements

The SSAF is managed by Diversity, Equity and Inclusion (DEI) which reports into the Executive Vice-President Resources portfolio. Decisions about how SSAF funding will be allocated are discussed by the SSAF Selection Committee, a delegated group of senior University representatives, with final recommendations developed by the Executive Director — Diversity, Equity and Inclusion taken to the Executive Vice-President Resources for endorsement.

Over a three-week period from 18th July 2022 students and DUSA as the key student representative body were invited to comment on the proposed priorities for use of the 2023 SSAF revenue. The proposed priorities for fee expenditure were published on the web and via other student focused communication channels. Students formally elected to University Committees and Boards were directly invited to comment and several discussions were held with the DUSA leadership.

Three submissions were received, one from Deakin's Student Union - DUSA, two from individual students.

After the challenges of COVID-19 throughout 2020 and 2021, 2022 was the beginning of a return to normal for the University. Deakin was proud to retain our position as first in Victoria for overall satisfaction for both undergraduate and postgraduate students and welcome back our international students in greater numbers, alongside improved engagement with our on-campus activities and initiatives.

#### Highlights in 2022

- Continued financial advice and welfare support for students experiencing distress
- Increased student numbers at Orientation events
- Meaningful engagement with on-campus events and campaigns
- Increase in fitness centre memberships and attendance
- Connected and holistic responses to students with mental health concerns
- Development of new student website
