Council Regulations | Version 2

The Council Regulations are amended as follows:

Part 8

1. The word "Initiatives" is inserted in the heading of Part 8 after the word "Faculties".

Regulation 17

- 2. The words "Initiatives and" is inserted in heading of Regulation 17 before the word "Institutes".
- 3. Regulation 17.1 is amended by inserting the words "*Initiatives and*" before the word "*Institutes*".
- 4. Regulations 17.2, 17.3, 17.4 and 17.5 are renumbered to become Regulations 17.4, 17.5, 17.6 and 17.7, respectively.
- 5. A new Regulation 17.2 is inserted as follows:
 - "17.2 Initiatives are large-scale, strategically aligned, multi-faculty research undertakings, characterised by broad intra-university collaborations (broader than one Faculty) and high strategic value".
- 6. A new Regulation 17.3 is inserted as follows:
 - "17.3 Institutes are located within Faculties reporting to their Principal Officer to undertake research, education and training renowned nationally and international for its excellence."
- 7. Regulation 17.4 (previously regulation 17.2) is amended by inserting the words "*Initiative and*" before the word "*Institute*".
- 8. Regulation 17.5 (previously regulation 17.3) is amended by inserting the words "*Initiative and*" before the word "*Institute*" in paragraphs (a) and (b).
- 9. Regulation 17.6 (previously regulation 17.4) is amended by inserting the words "*Initiative and*" before the word "*Institute*" in line 1 and omitting the words "*the Institute Board*" and substituting the words "*its Board*" in paragraph (a).
- 10. Regulation 17.7 (previously regulation 17.5) is amended by inserting the words "*Initiative or an*" before the word "*Institute*" in line 1 and the words "*Initiative or the*" before the word "*Institute*" in line 3.

Schedule 3

- 11. The heading of Schedule 3 is amended by inserting the words "*Initiatives and*" before the words "*Institutes Established by Council*".
- 12. A new subheading of "Initiatives" is inserted in Schedule 3;
- 13. The name "Deakin Applied Artificial Intelligence Initiative" is inserted under the new subheading of "Initiatives" in Schedule 3;

- 14. A new subheading of "Institutes" is inserted in Schedule 3 below the new subheading "Initiatives" and the name(s) of Initiatives recorded thereunder;
- 15. The name "Deakin Applied Artificial Intelligence Institute" is deleted from the list of Institutes recorded in Schedule 3.
