Research seminars, workshops, invitations, submissions and appointments

Sonia Allan was invited to submit to the Statutory Review Part 3A of the Assisted Reproductive Technology Act 2007 (NSW).

Additionally, the South Australian government tabled their response to the review of the Assisted Reproductive Treatment Act 1988 (SA) conducted by Sonia Allan from 2015-2017. The Hon. Peter Malinauskas, Minister for Health, thanked Sonia, stating the government had commissioned her due to her international expertise in the field. He then committed the government to establishing a donor-conception register, making the rights of donor-conceived people a main priority for South Australia, and implementing changes that 'best reflect Dr. Allan's recommendations'. Victoria enacted Sonia's model for access to information by donor-conceived people into law in March of this year, the first of its kind in the world; and now South Australia will follow.

Vicki Huang attended (remotely) Roundtables on intermediary liability & copyright on 13 and 14 November at QUT.

Marilyn McMahon organised a Roundtable on November 24 at Deakin Downtown on the topic *Do We need a New Family Violence Offence of Causing Psychological Harm?* Discussion focussed on the recent introduction of a relevant offence in England and Wales and a bill currently being considered by the Parliament of Scotland. Presenters included Marilyn and Paul McGorrery from Deakin Law School as well as Professor Heather Douglas, Associate Professor Julia Quilter, Helen Fatouros (executive director, criminal law services, Victoria Legal Aid) and Cassandra Wiener from the United Kingdom. The Roundtable was attended by practitioners and academics including the Director of Public Prosecutions (Victoria), the Director of Legal Services for Victoria Police, a representative of the Criminal Bar Association, Dr Heather Nancarrow (CEO, Australia's National Research Organisation for Women's Safety) and police prosecutors from Victoria and Tasmania.

Gill North made a policy submission entitled: ‘Small Amount Credit Contract and Consumer Lease Reforms: Exposure Draft Consultation Submission’ on 3 November 2017.

Gill also presented on ‘Responsible Lending Regimes: Theory, Evidence and Analysis’ at Banking & Financial Services Law Association Academic Symposium, 30 Nov-1 Dec 2017, Norton Rose Offices, Sydney.

Nicole Siller delivered a training for Dutch judges, public prosecutors and lawyers organised by the Training and Study Centre for the Judiciary (SSR) at their training day on the “Dutch International Crimes Act” on 10 November 2017 in Utrecht, NL. Nicole’s training focused on human trafficking under International Law and its incorporation within the crime against humanity of enslavement.

Nicole also participated in the high-level discussion entitled, ‘We Are Not Merchandise: Modern Slavery and Children in Institutions’ organised by the Missions of the UK, UAE, Bulgaria and Argentina to the United Nations at the United Nations Headquarters in New York City, NY on 28 November 2017.
